# MEMBERS PRESENT:

**PRESENTATION:** Champions for Change-Roxanne Bergheim, Emile Shapka, Dennis Shapka, Donna Desjardins, Judy Bogdan

- The Champions for Change Society is dedicated to people-centered, sustainable development for the purpose of advancing the common good, stimulating active citizen participation in community well-being and positively impacting the quality of life for St. Paul and area residents now and on behalf of future generations.
- Since 2006 Champions for Change has been involved in many community projects that fall into three themes: Downtown Revitalization, Creating Healthier Lifestyles and Caring for Children and Youth. To date we have five committees: Downtown Revitalization, Seniors Housing, Local Food Group, Thrive on Wellness, Children and Youth.
- October 5<sup>th</sup> is the 4<sup>th</sup> annual Harvest Ball where they promote local food and local food producers.
- Thrive on Wellness was supposed to be a 5-year program where they would have received \$10,000.00 per year. They did receive a letter that they were accepted for the funding, however there was a change in direction and they received notice that they will not receive funding. Alberta Health agreed to fund the program for one year.
- They partnered with Community Gardens to encourage more people to grow their own food.
- They will be setting up a collective kitchen where they will teach how to prepare and cook food.
- Mannawanis will provide their commercial kitchen for use.
- They may ask for letters of support for these projects.
- Senior Housing-they had a lot of different ideas come forth. They selected a group for Senior Housing and held a forum. Unfortunately they did not receive a good turn out from contractors. They will hold off on this for a little while and focus on their other big projects.
- Emile thanked Council for their support. A big part of Champions for Change success is due to the support from Council.
- When they started the committee they had short, medium and long term goals.
- Short Term Project-The Banner program is in its second year. They would like to expand the banner program to 51<sup>st</sup> street and 49<sup>th</sup> street; however the brackets needed for the banners are approximately \$125.00 each. They partner with the Town for Canada Day low cost family fun.
- Medium Term Project-Graffiti reduction. They will eliminate graffiti from Main Street and 51<sup>st</sup> Ave. They will make broader community awareness towards graffiti. There will be graffiti removal kits available to the public at no cost to the community. They will also have murals painted downtown. They would like to bring life to downtown by hosting outdoor concerts in the empty lot beside the Foundry.
- Long Term Projects-they have produced a scale model of what downtown could look like. They will have open houses so the community can discuss what they would like to see on Main Street. We could have bike paths and trees down Main Street. The IDP plan discussed possibly moving the trucking route out of St. Paul. Champions for Change are happy Council may consider this.
- St. Albert was voted best city in Canada. They budget yearly for revitalization. If Champions for Change had a fixed amount of income each year they could put up murals or stone structures.

- Suggesting to council that if each resident paid \$1.00 per month towards revitalization on their taxes that it would generate approximately \$26,000.00 per year. They are requesting long term funding for beautifying the town.
- Peavey Mart is offering a \$50,000.00 grant towards Thrive for Wellness.
- The Town of St. Paul has a strategic planning meeting each fall. Suggest that this is brought up at that meeting to see if we can plan long term funding to Champions for Change.
- Mayor Andersen thanks the committee for doing a wonderful job beautifying main street.

**Recreation Board** 

- Focus was in town last Friday and had one on one meetings with various groups to get their input of what their future plans might be and what they would like to see in our Recreation Facilities. Focus is developing a long term plan for the Town regarding our recreation facilities.
- May 31<sup>st</sup> June 2<sup>nd</sup> there will be a Midway in town. Gary is looking at trying to book for next year's rodeo. It will all depend on their schedules.
- The Clancy was officially shutdown on April 7<sup>th</sup> after the Brian Storeseth hockey Fundraiser. We still do not have a total of figures for individual groups to receive.
- Construction of extra washroom facilities at the Soccer Fields will be taking place this summer along with possibly the campground. Porta Potties have now been set up at JC, Reunion Station, Soccer Fields and Regional School.
- St. Paul minor ball will be selling advertising at Jaycee Ball diamond, they will be selling the fence advertising and looking after install and take down at the end of the season. St. Paul Cubs will be selling the advertising on the bleachers and also will be taking care of install and takedown.
- The fish pond was restocked with 900 more trout and will see 2500 added throughout the season.
- The campgrounds are both open as Barry and Brenda have arrived for the season. Sommerville has reserved 22 sites at the Iron Horse Trail Campground and 8 at the overnight trailer park. 14 stalls will be held for public and overnight use.
- The ground work has officially started on the Splash Park today. They are hoping for a July 1<sup>st</sup> opening as long as everything goes according to schedule.
- The Clancy Richard has been painted inside and new ceiling tiles installed. Cages have been removed from the dressing rooms 1 and 2 giving more space for the players. Dressing room 5 will be done at a later date. The shower stalls have been prepared to be tiled as well.
- The Aquatic Center is very busy with schools & lessons. Summer camps are being planned along with lifeguard courses & lessons. New exercise equipment has now been installed in the fitness room.

# **Don Padlesky**

- Attended the Annual Alberta Libraries Conference April 25<sup>th</sup> 28<sup>th</sup> in Jasper. Attended 5 speaker sessions. The real benefits from this conference were the networking.
- Attended the MD of St. Paul Foundation meeting on April 30<sup>th</sup>. Two items of interest were renovating the smaller rooms into bigger rooms and Sunnyside manor smoke shack room.
- Attended the North East Muni-Corr monthly meeting. The firm of Macdonald & Lawrence Timber Framing Ltd, who is conducting the repairs assessments for the trestle, gave their reports explaining in great detail which pieces need to be replaced and repaired. Phase 1 and 2 studies are now completed. Voted in favor to go ahead with Phase 3 and put together costs for work needed. Phase 1 costs were \$50,000.00, Phase 2 costs were \$90,000.00, Phase 3 costs were \$90,000.00.
  Phase 4 will be the construction phase. Performance evaluation forms were passed out to be completed and returned for the next meeting. Muni-Corr applied for a CFEP grant and received \$45,000.00 which is going towards the trestle project. ATCO power applied for a 10 year contract regarding right aways.

# Ken Kwiatkowski

 Attended the Alberta Library Trustees Association conference on April 25<sup>th</sup> – 27<sup>th</sup>. Attended the AGM. The guest speakers were good. Networking with other councilors was very good. It was interesting to hear that Municipal Affairs does get involved with negotiations between Towns and Countys. There were over 600 delegates at the conference.

# Evergreen Waste Management

• Jim Lindquist attended the meeting on May 9<sup>th</sup>. He is from Alberta Grazing Association.

- He said that Evergreen didn't show that they were in distress for the well and that is why Alberta Environment didn't approve the wells. He will be attending the appeal process for the water wells at Evergreen Waste.
- BRWMC has sent an e-mail saying that they will be signing a 3-year contract with Ryley.
- Our manager has said that our waste intake has increased.
- There are a couple of companies that are coming back.
- The commission has asked our manager to get an approximate amount of waste that these companies could be bringing in and see if they would be interested in a contract.
- Had a presentation from Jason Flatla from Ridgeline Greenfill. They are a company that does soil remediation for oil and gas companies. They treat all types of oilfield waste and turn it into cover for landfills. They have been in business for over 10 years. After his presentation he and our manager did a site visit and he will be back in a couple of months and will let us know what type of arrangement his company will be able to do for us.

### ADMINISTRATION REPORT

2013 Final Budget

- School Requisition has increased by \$232,562.04 which is an increase of 15.48%. The increase is passed onto the tax payer for both residential and commercial.
- The MD Requisition increased by \$53,195.77 (covers MD Operating costs) which is an increase of 3.98%. The cost is passed onto the tax payer
- The municipal Tax Mill Rate did not increase for residential and commercial tax payers.
- Taxes are based on the assessed value of both residential and commercial properties.
- Reviewed the budget recap which indicated revenue at \$5,867,691.00 and expenses at \$10,079,257.00 plus capital expenses of \$682,488.00. Net operating loss 2013-\$4,894,054.00.
