<u>PRESENTATION:</u>-Alice Herperger-Chamber of Commerce-Town Business License/Chamber Membership Fees.

- The Chamber of Commerce is recommending uniting the Town of St. Paul Business License with the Chamber membership fees.
- The Town business license fee would remain the same and there would be an additional \$115.00 added for the Chamber membership fee per license.
- The Town of St. Paul would be responsible for collecting the fees and forwarding them to the Chamber.
- With the proposed merge, using the assumption that there are approximately 335 business licenses issued in the Town of St. Paul, the Chamber can anticipate annual revenue of \$38,525.00.
- Currently 150 businesses out of 335 have a Chamber membership.
- The main use of the revenue will be to pay for a full time Executive Director. Other uses for the revenue are:
 - ❖ To create an economic business development package which will contain information on taxes and licenses pertaining to business, current development opportunities, sign ordinances/regulations, traffic impact assessments, etc.
 - Provide oil related camps in our area with information relevant to businesses in St. Paul.
 - Attend and host tradeshows to showcase employment opportunities and promote new business development.
 - Introduce a small business appreciation gala.
 - Continue to bring in guest speakers that help businesses succeed.
- When the Town is questioned why businesses are forced to pay the Chamber membership fees, the chamber recommends explaining that being a chamber member is being part of a community not a club.
- The Chamber sent out a survey to all businesses in Town to see if they are for or against the merging of the licenses and membership. They received 49 responses back and 82% of the businesses who responded approved of the united license.
- If the licenses and membership is combined the Chamber will no longer focus on fundraising. They will continue to fundraise however it will not be a priority.
- The Chamber would like only established businesses within the community to pay for a Chamber membership, out of town contractors will not be required to pay the membership.
- The Chamber of Commerce would like Town Council to take the first step and show other communities that the combined licenses are workable. They would like Council to take a leadership role and pass a By-Law that the Chamber membership is mandatory when they purchase a business license.
- Carstairs currently has a combined business and Chamber membership fee.
- Mayor Andersen thanked Alice for her presentation.

PRESENTATION:-John Quadros- Town Business License/Chamber Membership Fees.

- John has been in business in St. Paul for 16 years with his wife.
- John does not feel the Chamber offers any benefit to his business and does not want to be forced to pay a Chamber membership fee. He believes that if the Chamber is beneficial that he should have a choice to join, not be forced to join.
- John objects to the Municipality collecting fees and funneling them to the Chamber.
- He does not believe a municipal government should force businesses to pay a Chamber fee. He believes the municipal entity should be separate from the Chamber.
- John believes the Chamber should look within to see why businesses do not want to become members.
- He believes that forcing businesses to purchase a Chamber membership with their business license is a form of extortion. He suggests that Council look to see if it is legal to force businesses to purchase a Chamber membership.
- If the licenses are combined then businesses will lose their fundamental freedom of choice.
- Mayor Andersen thanked John for his presentation.

PRESENTATION:-Ryan Berezanski-Dog Barking Procedures

- Council was sent a barking dog package which includes a barking dog complaint form, a barking record and information on why dogs bark and solutions to barking dogs.
- In the complaint package the complainant must disclose if they are prepared to testify in a court of law. If they are not willing to testify no charges can be made.
- In order to issue a ticket there has to be reasonable evidence of an issue.
- Ryan does not believe our barking dog complaint package is excessive. He believes it is fair and will prove if there is an issue.
- If Ryan is called when there is a barking dog and he witnesses the dog barking, it is not enough for a Judge. The judge needs to know how the dog disturbed you.
- Ryan is willing to do mediation between the dog owners and the people complaining about the dog barking.
- Ryan will look into if we can offer some free courses to dog owners on why dogs bark and how to prevent or control the behavior.
- Suggested to make a By-Law that will state all dogs need to be inside by 10:00 pm.
- Our noise By-Law is the same as barking dog By-Law; the complainant needs to make a statement in order for charges to be made.
- Ryan will look into what can be done and bring back to Council.

 - 1. Usage only by employees of Sommerville and KDM Inspections.
 - 2. Personal vehicles, quads and boats are to be stored on site and not on the road.
 - 3. Land owner is responsible for garbage pickup and removal of garbage.
 - 4. Land owner is responsible to build a cabinet to store both the water meter and back flow preventer.
 - 5. Land owner is responsible for gravelling the site if necessary.
 - 6. No fire pits will be allowed.
 - 7. Location of this temporary site and any other potential future site cannot be located within 1,000 feet of a residential house. This area is determined from site boundary to residential house.
 - 8. Location cannot be anywhere on 50th Avenue.
 - 9. Land owner needs to communicate with surrounding businesses what the intent of the site will be (St. Paul Dodge, East End Rentals, Precision, Truck Car Wash, Jerry Bidulock).
 - 10. Land owner is responsible for weed control.
 - 11. Land owner will be responsible for the following charges for each trailer:
 - a. \$50.00 administration fee per month. The fee is calculated as follows based on two months:
 - i. \$55.00 administration fee.
 - ii. \$5.00 recycling fee
 - iii. \$26.00 water flat rate fee.
 - iv. \$14.00 sewer flat rate fee.\$100.00 for every two months.
 - b. Water meter consumption (1 meter). The landowner is responsible to give meter readings to the Town office monthly.
 - c. The sewer rate will be half the water consumption rate.

These rates are the same rates given to both Town and County Residents.

- 12. A maximum of 12 trailers will be allowed on site.
- 13. Land owner will be responsible for ensuring the above ground sewer line is secured.
- 14. Land owner is responsible for all environmental issues.

15. Land owner is responsible to ensure the site is cleaned up after trailers have left.

NOTE: The Town will only start these charges on August 1st based on 12 RV/Motorhomes.

These conditions are only for 2013 and the Town will review the conditions for 2014 if the RV Park site is required.

- Council recommends that #4 be changed to land owner is responsible to build a
 cabinet to store both the water meter and the reduced pressure backflow preventer
 as approved by Public Works and Water Treatment Plant Supervisors.
- Council recommends changing "trailer" to "RV/Motorhome".
