Ron Farmer, Store Manager for Five Star Pawn submitted requested additions/ amendments for the By-Law to Council.

Summary of Requested Additions/Amendments:

- A. Section 3 (1) (b) be amended to read "address" only (remove the word residential) so as to allow for post box numbers to be acceptable.
- B. Section 3 (1) (c) amend to require:
 - a. Recoding of the details from only one (1) government issued photo ID.
 - b. Mandatory *verification* of the person's identity from one (1) additional piece of acceptable ID (no details recorded).
- C. Add an exception clause for pawnbrokers, as per the clause for Second Hand Dealers (see Section 23 of By-Law) and add all of the exceptions in Section 23 to the clause.
- D. Add the following items to the exceptions for pawnbrokers:
 - a CD's
 - b. DVD's and blue-ray disc's
 - c. Video & PC (Personal Computer) games
 - d. Loose tools
 - e. Artwork or articles of jewelry sold by the original artist or producer
 - f. Any other items deemed exempt by the CAO
- E. Section 3 (1) (d) (e) (g)-Amend to exempt items listed in pawnbroker's exceptions (see point D above) from requirements pertaining to:
 - (d) recording Detailed description for *each good*
 - (e) recording Amount of money advanced for *each good*
 - (g) recording Inventory number for *each good*
- F. Section 3 (1) (g)-Amend to read "the inventory number for the transaction" (*which may include multiple lines and descriptions for goods within that transaction)
- G. Section 12B & 13-amend final line to read "...all in format and manner acceptable to the Chief Administrative Officer, and in compliance with Provincial and Federal privacy legislation"
- H. Section 26 (2) (a) amend to reduce first offence fine to maximum \$250.00 and reduce maximum fine for each subsequent offence, within a two year period to \$500.00.
- I. Section 26 (2) (c) remove this section (re: doubling fines for subsequent offenses) and remove related references to \$10,000.00 fine maximum (see Section 26-1).
