# MEMBERS PRESENT:

Mayor Glenn Andersen, Don Padlesky, Ken Kwiatkowski, Norm Noel, Judy Bogdan, Edna Gervais, Dwight Wiebe, Ron Boisvert CAO and recording secretary Cindy Litwinski.

### PRESENTATION:-Mr. Brian Storseth

- Mr. Storseth thanked Council for the time and opportunity to meet. He is here to see if Council has any concerns regarding the Government of Canada.
- New Building Canada Plan: When will the applications be available and what are the guidelines?
  - Will move forward with the Regional Economic Initiatives.
  - ❖ The parameters should be similar to the last time the grant was available with emphasis on water, sewer and roads. Funding is 1/3 Provincial, 1/3 Federal and 1/3 Municipal.
  - Hope the applications will be available early in the year.
  - The process is still being negotiated to have the application go to the Provincial Government first to prioritize projects.
- Deadline to apply for the Human Resources and Skills Development Canada (HRSDC) grant is January 31<sup>st</sup>, 2014.
- The Gas Tax will continue and has now been indexed into the budget. The Gas Tax funding has tripled for St. Paul since 2006.
- We need to prioritize our projects and give them to Mr. Storseth
- Looking at re-profiling the money that the Government of Canada gives regarding Highways. Would like to take the Federal money and prioritize projects. Would like to put more money into Highway 28.
- Will there be any funding for waste and recycling facilities? As the population grows we will run out of room for the waste. This is a problem all over Canada.
  - ❖ Landfills and Recycling Centers are not profitable for municipalities. Mr. Storseth would like investment money to develop ways to deal with waste and make it profitable for municipalities. Would like to try some pilot projects.
- Does the government have a website that will list all grants? Currently the government does not have one website for all grants. There are many different departments resulting in more than one website. Will pass this suggestion on. The best resource right now is to go see Mr. Storseth at his office.
- It is common for grants to be set up as 10 year programs.
- Budgets have increased by using per capita to determine funding allotments.
- Mr. Storseth was thanked for hosting his funding event in St. Paul in April. Mr. Storseth thanked Town and Council for extending their ice time by 1 week to accommodate the event.
- Temporary Foreign Workers-this is a great program and they have received a tremendous amount of applications. This is needed by the business community. Due to some abuse in the program it was almost shut down. They have made changes so there is a \$275.00 Labour Market opinion fee with each application.
- Mr. Storseth will forward the P3 guidelines to Mayor Andersen.
- Will bring forward a workshop in conjunction with the Chamber so businesses will know what is available to them.
- Mayor Andersen thanked Mr. Storseth for his contribution in Portage College receiving \$2.1 million.
- Keystone and Gateway Pipeline: the Gateway pipeline will have a traumatic impact on our community. It is currently before cabinet. Will keep pushing to have the Keystone pipeline approved. The safest way to transport oil is through the pipelines.
- Will be looking for Council support regarding the new addition to the reserve policy. The change in policy will allow any land to be turned into Reserve land. A reserve does not have to follow By-Laws or Environmental policies.
- Brain thanked Council and is looking forward to working with you.

- Muni-Corr has used their savings of over \$250,000.00 for Trestle repairs.

### ADMINISTRATION REPORT

• Recreation Board has proposed rate increases for renting our facilities. The rates have not been reviewed since 2006.
