PRESENTATION:-Automated Traffic Enforcement-Global Traffic-Richard Kracher & David Steer

- They provide a Turnkey solution that includes all approvals, implementation, signage and photo enforcement equipment.
- They use the same laser that the RCMP use combined with high resolution cameras that can shoot 360° and up to 400 meters away.
- They complete an evaluation with the RCMP and the Peace Officers to see what areas need to be addressed.
- There are no demerits associated with the photo enforcement tickets. The fine is registered with the courts and could go against a GST rebate if the ticket is not paid.
- Tickets are mailed in 2-3 business days.
- This system is not meant to replace the RCMP. It is to free up and enhance policing resources.
- They have a call center available for people who have questions regarding a ticket.
- They track all information including the payments.
- They are currently looking into enforcing distracted driving laws and are planning on rolling out the system this spring. Solicitor General states that they cannot mail tickets for distracted driving, they must pull people over.
- The license plate covers do not block the plate numbers when using laser. The covers are only effective on Radar.
- The system they are demonstrating will be attended at all times by one of the Global Traffic Group Peace Officers.
- Solicitor General guidelines state that the Town must be signed that there is photo enforcement. They also give warning tickets for 30 days when the system starts up.
- They can be at different locations during the day.
- They are recommending having enforcement 4-5 days a week for a total of 20-24 hours per week.
- The crown at Lloydminster is based out of St. Paul and is familiar with their systems.
- Global Traffic will cover the startup costs. They may ask assistance of Public Works
 to drill holes for the signage. They receive a portion of the ticket costs. The
 Province keeps 27% of each ticket; the remaining 73% is split between the
 Municipality and Global Traffic Group. The percentage Global will keep will be
 determined when/if we sign a contract.
- Their contracts are typically for 3 years; however they are flexible and would agree to a 1 year contract.
- Mayor Andersen thanked them for their presentation.

- Received a letter from Luckett Wenman & Associates (LWA) regarding a proposal for a sales-tax review (GST and other sales taxes) for the Town. We had a review completed in 2004 or 2005. It occupied a staff member for a couple of days and there was not much of a refund received.
- Received a letter from the St. Paul Senior Citizens Club thanking us for the grant received from the Town to cover traveling expenses for their educational and cultural trips during the year for seniors.

ADMINISTRATION REPORT

 Joint Regional Collaboration Program-Regional Emergency Management: would like to apply for the Regional Collaboration Program Grant. We would be partnered with the County of St. Paul, Town of Elk Point and the Summer Village of Horseshoe Bay. We would hire a consultant to help put the program together. Our current Director of Emergency Management is our Fire Chief. Our Town Hall and Recreation Centre is set up for emergency power.

- Setting up a Joint Council supper meeting with the County of St. Paul on February 13th, 2014 at the County Office. We will discuss the Waste and Recycling Agreement, Regional Emergency Plan and the Canada Build Grant.
- Received 4 letters from Five Star Pawn Ltd requesting to be exempt from Part one (1) Pawnbrokers, section Three (3) (D), Part Two (2) Secondhand Dealers Section Fourteen (14)(D), Part One (1) Pawnbrokers, Section Seven (7)(1), Section Nine (9), Part Two (2) Secondhand Dealers Section Seventeen (17) (1), Section Nineteen (19) of the Pawnshop By-Law. They are also asking for a letter of acknowledgement that a Pawnbroker is also a Second Hand Dealer. We received a legal opinion when we were revising the By-Law. There are no By-Laws in Alberta that allows a Pawnbroker to have exceptions. Recommend leaving the By-Law as is with no exceptions.
- Public Washrooms-The Chamber received a letter from a shopper who was upset because none of the businesses in Downtown St. Paul would allow her to use a washroom. The Town was approached last fall on installing washrooms downtown however there were concerns on where to put one and who would look after it. There were also concerns on who would pay to build the washrooms? Would the businesses build them or would the tax payer be charged for them? Most businesses in other communities accommodate their customers and have a sign on

- their doors that washrooms are for customers only. Will find out what Alice had in mind for a plan regarding washrooms downtown.
- Would like to set up a Social for the Mayors and Councillors from Town of Elk Point, County of St. Paul and Town of St. Paul. This will be a get to know each other event. No politics will be discussed. Will suggest March 17th, 2014 for the Social. It will be held in Elk Point.
- Evergreen Regional Waste Management Services Commission By-Law #12:
 Evergreen is repealing By-Law 1-2000 & 2-2000 and replacing it with By-Law #12.
 They are looking for a motion to support the By-Law and specifically support the retention of the weighted vote as set out in the By-Law. We will table this until the next Council meeting to allow Administration time to get more information on how the weighted vote and financing percentages were determined.
- Have received a letter from MS Society requesting a \$1,000.00 donation towards their MS Walk & Run in 2014.

"CARRIED"

- Affordable Housing: The Town of St. Paul finalized the purchase of Credit Union property (7.04 Acres) on January 12th, 2007 with the condition that we will donate 4 lots to the Affordable Housing Project at no costs. The only house they have built to date was constructed in 2005 and we had given this property to them. We did offer them a lot in 2007, for a duplex; however, they were not successful on grant applications. They have not built any more homes due to lack of grants and shortage of lots. On November 19th, 2008 the Town of St. Paul transferred .78 Acres to St. Paul Abilities Network for the Affordable Housing Project. SPAN applied for a grant under the Town's Name to build a 6 suite Apartment Block and when it was built it was expanded to 12 suites. The property is 300 feet by 70 feet, the equivalent of 6 lots. They have enough room to build another 12 suite apartment. Even though we did give a huge amount of property from the Credit Union to SPAN for Affordable Housing all the correspondence indicates that the 4 lots were directed towards the St. Paul Affordable Community Housing Society. We will continue to look for lots for St. Paul Affordable Housing.
- The Museum would like to build a shed. We need to have a site visit and have the Ag Society information at this meeting. The site meeting will be on February 6th, 2014 at 4:00 PM behind the CAP arena.
- That, we move into Camera at 22:05 Hours.
