Regular meeting of the Town of St. Paul Council in the St. Paul Town Council Chambers on Monday, April 14<sup>th</sup>, 2014 at 19:00 Hours.

# **MEMBERS PRESENT:**

Mayor Glenn Andersen, Ken Kwiatkowski, Edna Gervais, Dwight Wiebe, Don Padlesky, Norm Noel, Judy Bogdan, Ron Boisvert CAO and recording secretary Cindy Litwinski.

PRESENTATION: Ramona Arnett-Evergreen Regional Waste Management

- Reviewed requisitions for the Town of St. Paul: 2010-41.14% \$84,545.32, 2011-13.78% \$8,051.69, 2012-15.55% \$17,271.29, 2013 41.11% \$84,951.99. The deficit percentage is based on the tonnage from the Town of St. Paul.
- The Town of St. Paul brought in 1,121.32 Tonnes in 2013. The Private Companies from St. Paul brought in 3,676.07 Tonnes. 4,797.39 Tonnes have been allocated to the Town of St. Paul for a total requisition amount of \$84,951.99.
- The total Tonnes brought into Evergreen in 2013 was 11,668.99 and the total deficit is \$206,634.02.
- The Town of St. Paul has made great effort to reduce our waste. Why do we have to subsidize the private companies who are hauling waste to Evergreen?
- Waste Management pays a tippage fee when they bring in their waste, Companies in Town pay Waste Management to haul their waste and then the Town of St. Paul has to pay for any shortages. This seems like double dipping. Waste Management will start their route in Cold Lake and dump the waste at Evergreen and that waste is allocated to St. Paul.
- This is the way it has always been calculated however this is the first time the Town
  of St. Paul has seen the breakdown in tonnage. It is the first time they were made
  aware that they were paying based on the garbage that private companies were
  bringing in. The Town paying for private companies defeats the purpose of us trying
  to reduce our waste.
- In the past the Town was told that Evergreen would be covering their own deficits through a line of credit, reserves or operating. Evergreen should be run as a business and cover their own deficits.

# **COUNCIL COMMITTEE REPORTS:**

## **Edna Gervais**

St. Paul & District Chamber of Commerce

Attended the Inaugural Law Day on April 1<sup>st</sup>, 2014. It was very well attended.
There were approximately 250 people of all ages attending. The organizers were
very pleased and felt it was a great success.

- The executive Director's position is vacant. Five applicants have been interviewed but a final decision has not been made.
- A reminder about the ribbon cutting ceremony for St. Paul Value Drug Mart's new location will be held at 11:00 AM on May 1<sup>st</sup>, 2014. Everyone is welcome to attend.

## Ken Kwiatkowski

• Attended a workshop in Lac La Biche on March 12<sup>th</sup> & 13<sup>th</sup>, 2014. There were four modules: Legal responsibilities, Lending, Board Development and Community Economic Development. Each module was half a day. We had two or three group and individual exercises per module. We were given different scenarios and had to come up with a solution. I thought it was a very good workshop. There were 21 people at the workshop.

# **Community Futures**

- Held our regular meeting on March 20<sup>th</sup>.
- Penny Fox met with our MP and Minister Michelle Rembel and was told that there will be a few changes coming.
- There will be new regulation such as no board member will be allowed to hold their position for more than nine years. They will look at geographic's and gender when picking board members.
- St. Paul Smoky Lake has signed their one year agreement with the Government.

## **Don Padlesky**

Joint Fire Committee

- Presented the 10 year stats
- False Alarms have reduced due to a change in the By-Law. The Fire Department will respond to the first false alarm at no charge. If there is a second false alarm at the same location an invoice is sent out. The other reason the false alarms were reduced is because the County of St. Paul issues burn permits year round. This way when people see a fire burning off road and call 911 dispatch center they have records of burning permits locations and do not call the Fire Department.
- The County of St. Paul Pays 50% of fire operations.
- There will be a reserve account set up for highway calls such as accidents, fires and hazards. These calls are billed to the Alberta Government who then collects from the insurance companies. The dollars collected would be used for purchase of Rescue equipment between Ashmont, Mallaig and St. Paul Fire. Amounts collected in the past: 2011-\$11,200.00, 2012-\$13,200.00, 2013-\$24,000.00 and to date in 2014-\$11,200.00.
- The Quality Management Plans (QMP) has been completed and ready for signing off so they can be sent into the Safety Codes Council. These QMP's detail what our Fire Chief will be doing in regards to Fire Codes, Inspections and Investigations.

# St. Paul Library

- A Pet Therapy dog is brought into the Library for story time.
- The program reports will now be included with the Library Board Minutes.
- Yoga was offered in the Library from February to April at no cost to participants.
   Yoga fits into the Library's mandate for supporting health, wellness, information, continuous education and seniors' programming.
- On April 3<sup>rd</sup>, 2014 our Library hosted its annual Volunteer appreciation supper along with Friends of Library who hosted their AGM after supper. Our librarian Kerry Trottier has done fantastic improvements since taking over. Lots of renovations along with help of FOL fundraising ventures.
- Our own Councilor Ken Kwiatkowski was presented an award for years of service on the Library Board. Another award was presented to Irene Van Brabant for all of her work on the Library.
- There are an amazing number of volunteers putting in time at our Library at no charge. One young fellow who is blind does book shelve aligning and shredding once a week. Another retired couple takes care of the plants inside the building and the flower bed in front of the Library.
- Three of our Board members were voted on to FOL Board.

- April 10<sup>th</sup>, 2014 attended the regular Library Board meeting. Librarian Kerry is requesting the use of the Recreation Centre buff and floor polisher machine. Will forward the request to Gary Ward the Recreation Director.
- County of St. Paul has passed their budget and will give funding of \$40,000.00 to the Library in 2014.
- Were able to find a local paint artist from the MD Foundation of St. Paul who is going to paint a sign on the North East side corner facing the ball diamond and another sign above entrance facing east to Parking Lot.
- The Library will be partnering with FCSS and the Heritage Festival.
- Total Patrons for March was 2,538 and the Total Transactions were 2,129.

#### Other

A citizen in Town was given a warning for making a left hand turn over a solid line.
 The Fine is \$175.00.

# **Dwight Wiebe**

#### FCSS

- National Volunteer Week is April 6<sup>th</sup>-12<sup>th</sup>, 2014. The radio campaign is underway and about 6 community volunteers have been interviewed by SPUR Radio for the promotion and recognition of volunteers.
- We had a good response for the main street banner project and banners have been hung in time for National Volunteer Week.
- FCSS will host our annual volunteer luncheon on June 17<sup>th</sup>, 2014 at noon at the Reunion Station.
- Community Garden AGM will be held on April 23<sup>rd</sup>, 2014 at 7:00 PM. Will accept plot registrations beginning at 6:30PM. The additional eight raised Garden Beds will be placed as follows: 3-Townsite, 2-Elk Point, 1-Ashmont, 1-Mallaig, and 1-Vilna.
- The Boys & Girls Club has been approved for a \$19,000.00 Healthy Kitchens Grant through President's Choice.

- Have reviewed requests of support from groups. In 2015 we will move towards an application process and will time them near the end of the year so we know what funding is available.
- County of St. Paul FCSS have received a new food trailer (mobile concession) from St. Paul Co-Op. Co-Op has reserved the use of the trailer for 5 dates. Non-Profit organizations can book the use of the trailer through County of St. Paul.

- Attended Alberta HUB on March 27<sup>th</sup>, 2014. Is getting a better understanding of what HUB is and what it does.

- We have been approached to allow a temporary RV Park at 5013-40A Street. Last year we charged them a minimum of 12 sites regardless of how many trailers they had on site. They would like to change it so that they are charged based on how many trailers are on site on the first of each month. This item will be tabled until the next meeting.
- Received a letter from concerned citizens in Slave Lake requesting information on how we set up our Wellness Centre.
- Received a quote for crack filling at the airport. The asphalt repair is \$24,013.46 and the crack filler is \$18,750.00. Canada Build Grant has not established their guidelines yet. We can put the costs under operating and the Town and County of St. Paul will each pay for 50%.

The Town and County of St. Paul each contributed \$250,000.00 towards the Portage College housing.

## Evergreen Regional Waste

- Councilor Bogdan and Noel sit on the committee.
- The expenses have remained the same over the past few years.
- Evergreen should increase fees for private users.
- The Town of St. Paul is subsidizing the private users-this is double dipping.
- Even if St. Paul reduces its tonnage, we are being charged for private user's usage so our tonnage will not go down.
- If you add the requisition amount to our total tonnage charges it would be cheaper to not be a member of Evergreen and pay a higher tippage rate. If we were not a member we would not receive a requisition for Evergreen's deficit.
- Evergreen requisition will be tabled until next meeting.
