PRESENTATION: Rapid Response Unit-Trevor Kotowich

• Trevor Read the following letter to Council:

The St. Paul Fire Department is currently comprised of 32 dedicated volunteers and one full time Fire Chief that cover the Town of St. Paul and an area of just over 1,000 square kilometers of the County of St. Paul. The Fire Department provides fire suppression, vehicle rescue and medical assistance as requested. In addition, members also take part in fire prevention and awareness activities. On average the St. Paul Fire Department responds to 175 incidents each year.

In 1992, members saw the need to raise funds for vehicles and specialized equipment that would not normally be covered through municipal budgets. It was then that Lakeland Safety Services Association, a not-for-profit entity was founded under the Societies Act (#505174987). Since then, hundreds of thousands of dollars were raised through donations, fundraising events and municipal support to purchase Rescue vehicles, a mini-pumper, specialized rescue tools (Jaws of Life) and staff training to just name a few.

We have once again undertaken an aggressive fundraising initiative to replace the 1994 Rescue truck currently in use, with a more modernized Rapid Response Vehicle with the ability to carry 300 gallons of firefighting water and foam. In addition, this vehicle will carry all the specialized rescue equipment such as hydraulic tools and rams, stabilizing kits, ventilation fans, spare air packs and cylinders. Because of its smaller stature compared to larger Rescue Trucks, it will have the ability to access the Iron Horse Trail and other areas that are being used as recreational vehicle access points. In addition, this vehicle will be used to attend any medical assistance calls as requested by EMS, and would carry basic medical supplies such as an AED, oxygen administration and first aid supplies.

The vehicle itself will have a Rescue Squad box custom built and attached to a Ford F-550 chassis. As mentioned it will have a built in pump and tank which will also be useful to attend to any wildfire incidents. The cost for this new Rapid Response Unit is just under \$200,000.00 complete with all equipment and accessories. A CIP (Community Initiatives Project) application has been sent in requesting \$75,000.00 in funding support. In addition, we have received some interest from Industry partners which may look at assisting with some of the funding. However, without the commitment of both our local governments, this project will not proceed. Our members have committed themselves also to raising funds for this project through various activities.

- Trevor is looking for a letter of support for joint operations and maintenance of the new Rapid Response Unit.
- Trevor is asking that the Rapid Response Unit be added to the Strategic Planning Agenda.
- One set of Jaws of Life are non-functional right now. He is hoping the mechanic can repair them. If they cannot be repaired it will cost \$45,000.00-\$50,000.00 to purchase a new set.

- In September attended the Northern Development Alberta Council (NADC) meeting. They have sent correspondence regarding what they have done regarding concerns that were brought up. ADMINISTRATION REPORT

Employee Incentive Program

- Currently all staff and the volunteer fire department are permitted to use the pool facility for free during regular hours of operation (does not include family members). This pass is valued at \$400.00. There are currently two staff members using this pass.
- Management is suggesting that we consider offering staff members a family pass for the pool. The family pass is valued at \$580.00.

- Photo Radar Summary during warning period: They worked 47 Hours and 25 minutes. They issued a total of 146 Warnings which included 1 Red light warning, 14 Stop sign warnings and 131 speed warnings. 55% of the tickets issued were to St. Paul residents and 45% were non-residents. They had 6 multiple infractions that were not sent out and 9 out of Province warnings that were not sent out.
- We need to sign a Regional Emergency Management Mutual Aid Agreement between the Town of St. Paul, County of St. Paul No. 19, Town of Elk Point and Summer Village of horseshoe Bay regarding sharing of resources during an emergency.

- Ron, Gary and Mayor Andersen participated in the AAMDC golf tournament in Athabasca. They discussed the possibility of St. Paul hosting the tournament. AAMDC is interested in having St. Paul host the tournament in 2015 and we have put them in contact with Jarrod from the Golf Course to make arrangements.
- Survey/Boundary Panel: we have two blocks that were out of proportion. The case is now with the courts and it should be resolved in a couple of weeks. The courts will determine where the boundaries should be.
- Budget to Actual ending October 31st, 2014 were sent out to Council. Please see Ron if you have any questions.

AUMA Convention

- While at the AUMA Convention we had discussions with Alberta Transportation regarding concerns with some of our roadways. We have received a response to the concerns as follows:
 - 57 Street and Highway 29: Following the site visit completed on September 16th, 2014, the department's Athabasca operations group will review and advise about speed limit transitions, traffic signal warrants and possible cost sharing.
 - Future Improvements to Highway 29 and highway 881: Currently there are no projects on the current Three-Year Construction Program for either Highway 29 or Highway 881. In the meantime, the department will continue to monitor the condition of the highway and schedule necessary work as required.
 - Traffic Lights on 48 Street and Highway 29: It appears that the traffic timing issue at the intersection of 48 Street and Highway 29 was resolved during the September 16th, 2014 site visit.
- Rumble Strips on Highway 881: the only way to remove the rumble strips would be to overlay the road.
- Rapid Response Unit: Would like administration to look into who owns/insures the 1994 Truck that would be replaced with the new Rapid Response Unit. Would like to see if someone in our County could use the 1994 unit instead of selling it. Trevor is requesting a letter of support for the purchase of the Rapid Response Unit.
