Meeting of the Town of St. Paul Council in the St. Paul Town Council Chambers on Monday, January 26th, 2015 at 19:00 Hours.

PRESENTATION:-Northern Lights Library System (NLLS)-Mircea Panciuk

- Mircea handed out documentation to Council on Northern Lights Library System.
- The documentation included information on their E-Resources, The Regional Automation Consortium and their 2014-2017 Plan of Service.
- As of December 2013 reports showed 40,590 active TRAC/TAL cardholders belonging to the libraries in NLLS.
- A December 31st, 2013 "snapshot" showed that St. Paul Municipal Library has 1395 patrons that belong to the Town of St. Paul. St. Paul Municipal Library also has 592 patrons that belong to the County of St. Paul and 108 patrons belonging to other municipalities.
- NLLS ordered 23,490 books in 2013 for a total cost of \$355,376.18 or an average of \$15.09 per book. There was an average discount of 37.50% for these books for a realized saving of \$106,972.67 or an average savings of \$4.54 per book.
- St. Paul Municipal Library received 389 of these books at an average cost of \$35.73 per book and received an average discount of 37.50%. The realized savings for the St. Paul Municipal Library was \$4,183.50 or an average savings of \$10.75 per book.
- NLLS and its partner libraries have 712,320 items that are catalogued and on the Polaris Integrated Library System (ILS) TRAC (The Regional Automation Consortium) which includes NLLS has 3,275,498 items that are catalogued and on the Polaris ILS.
- Statistics from 2013 reported by NLLS and 45 of its partner libraries indicated that 737,498 items were circulated by NLLS Libraries.
- St. Paul Municipal Library circulated 30,320 items in 2013. St. Paul Municipal Library circulated 134% of their collection in 213.
- Statistics from 2013 reported by 45 of NLLS partner libraries indicated that 457,900 interlibrary loans were done.
- St. Paul Municipal Library had 34.89% (7,876) items of their collection out on Interlibrary Loan in 2013. St. Paul Municipal Library borrowed 8,756 items in 2013 or 38.78% of their collection. Borrowing these items saved the library an average of \$25.44 per item or \$222,752.64. St. Paul Municipal Library interloaned 16,632 items in 2013.
- Electronic book usage has increased from 374 items checked out in 2010 to 3,044 items checked out in 2013.
- NLLS provides to the St. Paul Municipal Library: Shared TRAC Services, Resource Sharing Services, Bibliographic Services, Public Services, Information & Technology Services, Administrative Services and Infrastructure Costs and Computer Replacement Program.
- Mircea thanked the Town of St. Paul for their continued support of Northern Lights Library System.
- On behalf of Council Mayor Andersen praised Mercia and the NLLS Board for all that they do. We appreciate the service.

PRESENTATION: -St. Paul Journal-Janani Whitfield

- Janani has been attending Council meetings for the last 7 years.
- A number of other communities use the newspaper as a method to communicate with their residents. Janani handed out samples of what other communities are doing.
- She is here to make a proposal to Council to consider advertising on a regular basis.
- St. Paul Journal Proposal to the Town of St. Paul (Prices are negotiable):
 - Full Page Ad
 - Regular cost advertising all year=\$42,744.00
 - 35% discount, running weekly ad=\$27,784.00
 - 35% discount running bi-weekly ad=\$13,892.00
 - Half Page Ad
 - Regular cost advertising all year =\$34,320.00
 - 25% discount, running weekly ad = \$25,740.00
 - 25% discount, running bi-weekly ad = \$12,870.00
 - Black and White print prices have been quoted, however they will include color printing for free.
 - Provisions:
 - The page can be used by Town of St. Paul or any of its departments or facilities.
 - The page can be used for By-Laws, development permits, notices or employment ads.
 - Design is included; they can provide PDF's to be put up on their website and the Town's website.
 - Space must not be used in partnership agreements or for the use of other Town groups or clubs.
 - Does not include any extras/special sections.

 - ❖ Subtotal \$199.60+\$9.98 (GST) =\$209.58. Note: this is at their cost, regular pricing would include a markup of 20% for a total nightly cost of \$239.52
- Would like to share this information with businesses in Town to see if they would like
 to share in the cost. If businesses shared in the cost we could have coverage every
 night. We will ask the Chamber of Commerce to share this information with their
 members. We will ask Lakeland Security Services to make a presentation on March
