Interested in subdividing?

As of **October 29, 2018**, the Subdivision Authority for the Town of St. Paul will be Town Council. Subdivision applications will be received by Panning and Development staff. Council will consider all applications with support and recommendations from staff and professional planners. Council will make the final decision on any proposals in accordance with adopted planning processes and provincial legislation.

Applicants/Owners are encouraged to drop by and pick up a subdivision application or go online at https://townstpaul.civicweb.net/Portal/ then click on Document Center>Forms>Planning and Development>Subdivision ApplicationPackage at their convenience.

Pre-application meetings are encouraged before an application is filed to assist you in your preparations.

It is important to plan ahead! Submit your subdivision application **<u>now</u>** if you are planning on building on the proposed lot in 2019! The timeline for a standard one or two lot proposed subdivision, can take between 3-5 months to be registered. This timeline includes but is not limited to: file acceptance, 21-day referral period, decision by Town Council, applicant/owner to complete their conditions of approval (if approved), obtain your survey, and registration at the Land Titles Office.
