The purpose of the public hearing is to obtain public input on proposed Bylaw No. 2019-01:


1. That Part "11" of the Town of St. Paul Bylaw Land Use Bylaw 1242 be amended such that all portions of Lot 1, Block 36, Plan 5341KS as shown on Schedule "A" be rezoned <u>from</u> Highway Commercial District (C2) <u>to</u> Residential Medium Density District (R2).

BYLAW 2019-01 OF THE TOWN OF ST. PAUL

A BYLAW OF THE TOWN OF ST. PAUL IN THE PROVINCE OF ALBERTA TO AMEND BYLAW NO. 1242 BEING THE LAND USE BYLAW OF THE TOWN OF ST. PAUL.

WHEREAS Council has adopted Town of St. Paul Land Use Bylaw 1242 to be used as the Land Use Bylaw.

WHEREAS it is deemed expedient to amend Bylaw 1242 as set out in Section 692 of the Municipal Government Act, R.S.A. 2000, c. M-26, and amendments thereto.

NOW THEREFORE under the authority and subject to the provisions of the Municipal Government Act, and by virtue of all other enabling powers, the Municipal Council of the Town of St. Paul, Alberta, duly assembled, hereby enacts as follows:

- 1. That Part "11" of the Town of St. Paul Bylaw Land Use Bylaw 1242 be amended such that all portions of Lot 1, Block 36, Plan 5341KS as shown on Schedule "A" be rezoned <u>from</u> Highway Commercial District (C2) to Residential Medium Density District (R2).
- 2. This bylaw shall come into effect upon passing of the third reading and final reading.
