Hello St. Paul, hope you are enjoying our wonderful weather. I'm almost afraid to acknowledge it as we all know how quickly it can turn the other way. Fingers crossed we have seen the last of the winter weather.

As you are all aware we have been subject to a bit of crime spree as of late with many homes and businesses being vandalized or broken into. In an attempt to mitigate this issue, the Town is trying a bit of an experiment with a local security company. We are paying for 16 hours a week for this company to patrol our streets at night

and notify the RCMP if they see anything either suspicious or any crimes in progress. To date they have certainly been active and quite busy with these duties. At the end of three months' council will re-evaluate the success of this pilot program and decide whether it is of value to our community.

In the mean time I want to bring your attention to a program called Crime Prevention Through Environmental Design (CPTED). This program is the science around the design and effective use of physical space to lead to a reduction in both the incidence and fear of crime. CPTED seeks to reduce both opportunity and the number of targets for criminals.

There are four basic strategies in CPTED:

1. Access control

2. Surveillance

3. Territorial reinforcement

4. Maintenance

The main principle behind CPTED seeks to "harden" or reduce the attractiveness of potential crime targets. Aspects such as locks, windows, doors, fencing, cameras, lighting, and vegetation control are just some of the tools of CPTED. While no one wants to be the victim of crime, there certainly are some things one can do to reduce the potential of becoming a victim. Ensuring proper lighting is maintained in your yard, ensuring valuables are out of sight and locked up will certainly go a long way. St. Paul Municipal Enforcement Peace Officer Ashdown has taken the first part of the CPTED training last fall through the Edmonton Police Service. CPO Ashdown is working collaboratively with the business community to ensure the message gets out, and to offer his assistance in evaluating local businesses. For enquiries about CPTED please call the Town Office and ask for Municipal Enforcement. Remember prevention is the best medicine.




