# **Highlights from the Mayor**



I feel like we've gone from Winter to Summer in the blink of an eye. After complaining about the cold I feel I shouldn't really complain about the heat, but wow it was hot! Anyway on to more important things.

Several points I want to touch on, first of all unleashed dogs in our parks. We have had a few complaints about people running their dogs off leash in Lagasse Park. Until such

time as a final decision is made on the location of a dog park by Council, all dogs must be leashed when walking on town land, (parks included). Not everyone is a "dog" lover and some folks are genuinely frightened of dogs. So please be considerate of those folks and hopefully in the coming weeks a decision on the location of a Dog Park will be made and we can get a fence up and then the dogs can run unleased within those confines.

In regards to the dog Park, by the time you read this you will have received a survey about the location of the dog park in your utility bill. There are seven options for you to choose from as well as a suggestion for any locations not mentioned. This survey will also be on Facebook and our website, so you have the options of filling it out online or filling out the paper copy that was in your utility bill and sending it back in, or dropping it off at the office. We want to hear what you think about the location of a Dog Park. Most towns have a Dog Park and we feel it would be appreciated by dog owners in our community, however also want to put it in a place that has the least amount of concerns for everyone in town. Please fill out the survey and let Council know which location you think is best.

Another issue we are currently dealing with is, a few of our residents placing sheds, fences, gardens and even parking slabs on Town property. Over the next year or so Bylaw Enforcement will be notifying those residents that anything encroaching on town land will have to be moved. If you have such a structure, be it a shed or anything that should be within the confines of your lot, it would be better if you could just move it back on to your own property. Though ample warning will be given, we ask that you don't risk a fine, and move the intruding structure as soon as you can.

Just a quick reminder that the nomination period is open for anyone considering running for Council. Please check our website for a nomination package and any information you may need.

# Dog Park Location – Public Input Needed


The Town of St. Paul is asking for Public Feedback regarding the future home of a Dog Park within the Town. Please see below the following options:
