PROPERTY TAX DEADLINE **JUNE 30**
A 10% penalty will be applied on current tax levy on July 1st, 2025.

PAYMENT INFO

The due date for payment of property taxes is June 30, 2025. All payments received after June 30, 2025 are subject to a 10% penalty on current tax levy. The Finance Department will issue statements to those with amounts still owing in the Fall prior to the next penalty date, being January 1, 2026, when a 15% penalty will be applied.

METHODS OF PAYMENT

- **Telephone or internet banking** through your financial institution (your roll number is your account number)
- **Mail** | It is your responsibility to be aware of the potential **Canada Post Strike** (please make your cheque payable to Town of St. Paul)
- **In person** at Town Hall by cash, cheque or Interac (please check with your financial institution to ensure your single transaction limit is sufficient).
- **Credit Card:** Payments will only be accepted through **Optionpay**, a 3rd party provider, with all fees associated being the responsibility of the cardholder. This format will be accessible on our website as well as in person.
- **Installment Plan:** The Town of St. Paul has a tax installment plan to help town taxpayers budget their property taxes. To be eligible for the plan you will need to make payments in a pro-rated amount for the year first. All previous years must be paid in full as well.

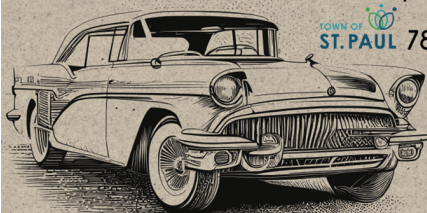

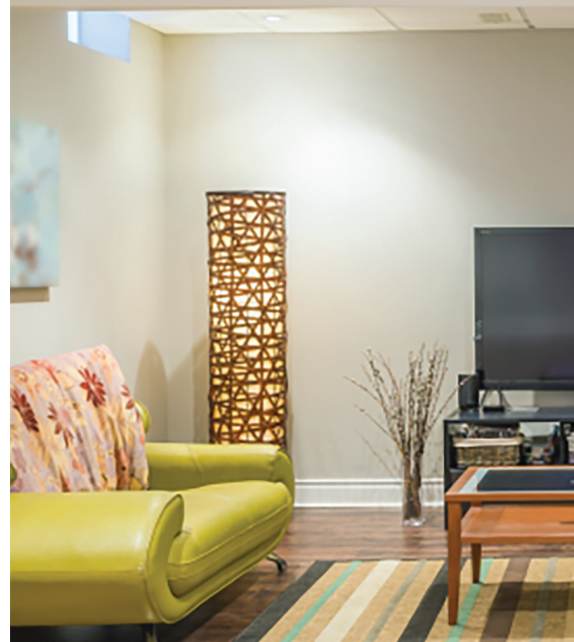
